Executive departures and public statements. A central issue in relation to a sensitive or senior executive departure will often be the external and/or internal reason for departure – whether articulated in a press release, reactive statement or reference.

## **Executive departures and public statements - Personnel Today**

Announce new appointment fast. When a bland statement is issued, the rumor mill will certainly get going, and so management should act as quickly as possible to announce a new appointment or restructure or new responsibilities for existing executives. The announcement will put focus back on the organization rather than on the individual who has left.

## **Abrupt executive departures cause communication problems ...**

This may lead to a press release that does not shower the outgoing executive with praise, therefore signaling a less-than-favorable view of the executive. Or the announcement may state the departure is by “mutual decision,” again a clear signal. Communicating CEO departure is a delicate balancing act.
